This coming year holds the promise of even more excitement as Missouri Western celebrates 100 years of transforming the lives of our students. As we spend the next year appreciating our past, we will also look forward to the University’s great future.

With a look to that future, we have recently launched a master planning initiative to study our physical space campuswide and to see what the future may hold.

We kick off our Centennial year in January 2015, which will involve a full calendar’s worth of special events and communication pieces celebrating our fantastic history and promising future. Coinciding with our Centennial celebration, we will kick off a Centennial Capital Campaign in January 2015. Foundation Highlights

July 1, 2013 – June 30, 2014

- Contributions received by the Foundation for FY2014 totaled \$2,972,283, which included \$230,518 in gifts-in-kind. Net assets grew by \$4,258,204 in FY2014.
- The Foundation awarded scholarships totaling more than \$806,082 to 528 students, an increase of more than \$80,000 from FY2013.
- The Foundation's Student Excellence Fund awarded 118 students a total of \$41,000 so they could attend and present their research at national and international conferences. Twenty-two students presented at conferences in Greece, Malta, and Croatia as part of a study abroad trip. Additionally, the Blake Scanlon Applied Learning Grant awarded \$8,600 to 12 students.
- Five new scholarships were established in FY2014:
 - Craig School of Business Scholarship Endowment
 - William Wright Endowment for Student Scholarships
 - Anne Reed Gray Memorial Arts Scholarship
 - Dr. Joseph and Gladys Friedman History Scholarship
 - Psychology Chairperson's Research Scholarship
- The third annual Engineering Technology Awards Banquet was held in March, honoring student Ian Micah White and community member Don Coleman. The banquet, which supports the Department of Engineering Technology, is funded by generous sponsors, thanks to the efforts of the Engineering Technology Advancement Committee.
- The Missouri Western Ambassadors raised more than \$12,000 at its 2014 Night at the Ritz – Ritz Under the Stars – in April. All proceeds go to scholarships for nontraditional students.
- The 2013 R. Dan Boulware Convocation on Critical Issues featured historian Dr. Doris Kearns Goodwin and the 2014 R. Dan Boulware Convocation on Critical Issues will feature historian and Cronkite biographer Dr. Douglas Brinkley.
- The Foundation received \$464,261 on behalf of Missouri Western Athletics from Gold Coat members, corporate sponsors, contributions and fundraising activities.
- Zack '74 and Mary '76 Workman made a pledge to the Foundation to create an academic resource room in the Griffon Indoor Sports Complex for student athletes.

Looking back, looking forward: Everything is possible

As Missouri Western approaches its Centennial celebration in 2015, it is appropriate that the University celebrate its past, but also look forward to its second century.

Looking back

July 1, 2013 - June 30, 2014

Walter Cronkite Memorial opens

The new Walter Cronkite Memorial in the Spratt Hall atrium was dedicated and officially opened on Nov. 4, 2013, the 97th anniversary of Walter Cronkite's birth.

Approximately 400 people, including Gov. Jay Nixon and Walter's daughter Kathy Cronkite gathered to dedicate the permanent memorial. The 5,000 sq. ft. memorial contains interactive kiosks and displays designed to honor the legendary CBS Evening News Anchor, born in St. Joseph, Mo. in 1916. The memorial was the vision of Dr. Robert Vartabedian, Missouri Western's president.

"Walter Cronkite is probably the most significant journalist of the 20th century," said Dr. Vartabedian. "Generations of Americans

counted on him for reports on major events. He was respected by his colleagues and by the people he covered, and I'm pleased that we're able to honor him in this way."

The memorial was made possible with funding from the David and Shirley Bradley Endowment.

Since it opened, a bronze bust of Cronkite and more displays has been added to the space. Visitors also have the opportunity to view a planetarium show narrated by Cronkite in the Bushman Planetarium in Agenstein Hall, "Future Moon." Another addition is "Cronkite," a live, multimedia presentation. Featuring a professional actor, the show is an adaptation of an interview with Walter Cronkite by Larry King on the first anniversary of 9-11.

The memorial earned significant recognition when it received the Missouri Division of Tourism's Spotlight Award at the 2014 Missouri Governor's Conference on Tourism in October.

Arts advocate supports Missouri Western

In FY2014, Bill Wright made a \$50,000 gift to the Missouri Western State University Foundation to establish an



endowed scholarship fund for Missouri Western students in the arts – music, art and theatre. He also notified the Foundation that it will be a beneficiary of almost \$500,000 for the scholarship fund from his estate when he dies.

"I was impressed by everyone I met in the arts programs. There is incredible potential for





the arts at Missouri Western,” Wright said. “Faculty members are excellent and incredibly talented; they are world class people.”

With Dr. Laurel Vartabedian and Karen Graves, Wright helped found the Missouri Western Arts Society in 2011 to raise money for the arts programs, and he served as chair of the leadership council for two years. Additionally, he has helped fund student trips to the Kansas City Lyric Opera and the Kansas City Repertory Theater.

“I had the money, and it was time to start seeding it to make things grow. I hope other people will get the idea, too,” he said.

Family’s gift creates beautiful space on campus

Students have a new place to gather on campus, thanks to the generosity of a local family. In April 2014, the University dedicated the Kelley Commons, a beautiful outdoor patio outside the Blum Union.

It is named for the Kelley family, which includes the parents, Jean Kelley and the late James Kelley; children, Jeanie Grahl ’72, Molly Pierce ’77 and Chris Kelley ’86, his wife, Kelly; daughter Kelsey; Kelley Meirose ’99 and her husband, Scott.

In 2007, the family donated funds to create the University Plaza, which includes the 10 ft. bronze Griffon statue and fountain. The new Kelley Commons is close by.

“It was a great natural extension of the plaza, and we are very happy with the results,” Pierce said.

The Kelley family donated \$100,000 toward the project. The Student Government Association contributed \$20,000 for furniture for the Kelley Commons and for the first floor lobby of the Blum Union. Aramark Campus Dining contributed \$6,000 and Zack Workman ’74, owner of Lawns Unlimited Inc., donated landscaping and dirt work for the new space.

The space includes a large patio area with tables and chairs, a stage, a grassy area, and large black and gold sails to provide shade. Inside the Blum Union, adjacent to the patio, is a new Java City.

Ann Pearce, special assistant to the president; Brian Shewell, former student representative on the Board of Governors; and Dr. Laurel Vartabedian coordinated the project.

Looking forward

Two initiatives reflect the vision for Missouri Western’s future as the University prepares for its 100th anniversary: a Centennial Capital Campaign and comprehensive master planning.

Centennial Capital Campaign

In early 2015, Missouri Western will kick off a Centennial Capital Campaign. The campaign is currently in the planning stages, and the Steier Group has been hired as a campaign consultant.

Last summer, co-chairs for the Centennial Capital Campaign were announced – R. Dan and Dale Boulware and Dr. Mark and Mary Margaret Laney.

“As we prepare to celebrate 100 years of transforming lives and carry that legacy into the future, we’re thrilled that Dan, Dale, Mark and Mary Margaret have agreed at this stage in the planning process to provide leadership for the Centennial Capital Campaign,” said Jerry Pickman ’85, vice president for University Advancement and executive director of the Missouri Western State University Foundation.

Missouri Western is currently securing leadership support and further defining campaign goals.

“As leaders in the St. Joseph community, the Boulwares and Laney

share a great passion for the future of our community and recognize the role Missouri Western plays in the region’s prosperity and continued economic growth,” Pickman said. “I am truly grateful to partner with such wonderful advocates of our University.”

Comprehensive master plan

Missouri Western began a comprehensive master planning initiative in the summer of 2014, and a report is scheduled to be available next spring.

Pickman guided the process of selecting the architectural firm Clark-Huesemann of Lawrence, Kan., for development of the master plan. He said the plan will establish a framework for physical growth over the next 10 years and will help guide the University’s decisions regarding new construction and renovation, traffic patterns, accessibility, environmental stewardship, parking, land development, and classroom and other space utilization.

Ann Pearce, special assistant to the president, is heading a master plan steering committee.

“It’s important for us to make sure that we have the physical structure to support student needs into the future,” she said. “The process will be thoughtful and very strategic.”

A master plan is especially important, Pearce said, since a long-term land lease bill was signed by Gov. Jay Nixon in July. Previously, state law included a sunset clause which prevented most universities from leasing their land beyond 2017. The new law opens up opportunities to enter into long-term leases on campus.

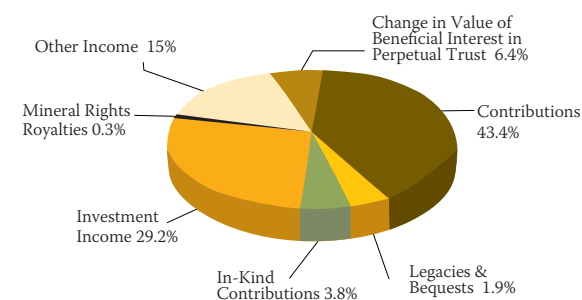

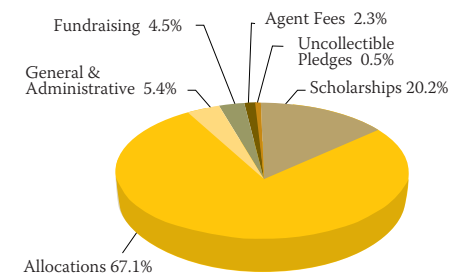

Undesignated gifts provide extras

While many gifts to the Foundation are designated for a particular project or scholarship, many gifts are undesignated, which provide outstanding extras for students that may not otherwise be available.

Each spring, faculty members and staff across campus submit requests for funding from the Allocation Committee of the Foundation Board of Directors. For the academic year 2013-14, the committee allocated \$44,820 for 17 projects and programs. Some of those that were funded are listed below.

Visual Arts Day – The second annual Visual Arts Day brought more than 900 high school students to campus from all over the region. The day included a juried high school art exhibition, art competitions and events, and studio workshops in clay, graphics, animation, printmaking, photography, drawing, design and sculpture. The Foundation also helped fund four more programs for high schoolers in FY2014: a regional science fair, Chemathon, High School Writing Day and Foreign Language Day.

Listening Assist – The Foundation funded a listening assist system for Potter Hall Theater for patrons of student performances and the Western Playhouse summer theatre program. Thousands enjoyed performances in the Potter Hall Theater in the 2013-14 season.

Visiting Artists – The Department of Art hosted visiting artists from around the globe in the Potter Hall Art Gallery. The artists exhibited their works in the gallery, conducted workshops for students and created an original piece of art in the studios.

“Magic Flute” – The Departments of Art and Music collaborated to produce “Magic Flute,” by Amadeus Mozart. It was performed in Potter Hall Theater in November 2013. Art students provided digital animation for the production and music students lent their singing talent for the opera.

Peace and Conflict Studies Speaker Series – Missouri Western began offering a minor in Peace and Conflict Studies in Fall 2013, and three speakers visited campus during the academic year to supplement the studies in the new minor. The minor is a collaboration between religion, legal studies and political science, and the three speakers reflected each of those disciplines.

President's Centennial Circle

Drs. Robert and Laurel Vartabedian made a personal financial commitment of more than \$100,000 to Missouri Western to establish a new donor recognition program called the President's Centennial Circle. The President's Centennial Circle recognizes donors with a lifetime history of giving \$100,000 or more to the University.

"I really believe in this University and in this community, and Laurel and I wanted to show that in a tangible way," said Dr. Vartabedian, who became University president in 2008.

The Vartabedians have pledged a total of \$144,000 to the future campaign. Most of the gift is undesignated at this point, but a small portion is supporting the revival of a speech and debate team at Missouri Western.

Shortly after the Vartabedians' gift was announced, Dr. Robert Willenbrink, the founding dean of the School of Fine Arts, and his wife, Susie, joined the President's Centennial Circle with a \$100,000 pledge.

"The Willenbrinks' gift is sincerely appreciated, and their generosity helps us with our Centennial Capital Campaign efforts," said Dr. Robert Vartabedian. "We are grateful for their support and commitment to Missouri Western."

Dr. Willenbrink said the gift is a way of expressing their deep commitment to the University's programs and students. "I believe the capital campaign is important to the future of Missouri Western and to our region."

The Foundation is preparing for a capital campaign in conjunction with Missouri Western's Centennial celebration in 2015. The two gifts help jumpstart the planning efforts for that campaign, said Jerry Pickman '85, vice president for University Advancement and executive director of the Foundation.

"Donors want to know that the people seeking their financial support are themselves deeply committed to the cause," Pickman said. "These gifts are a strong demonstration of that commitment."

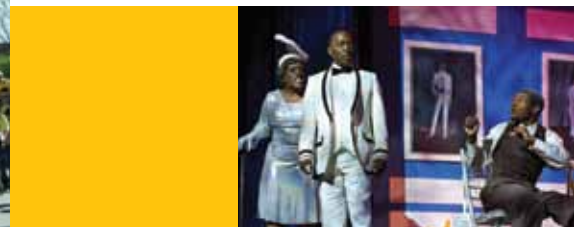

Ways to Give

There are many ways you can make a difference through gifts to Missouri Western. From outright contributions to planned giving, there are many opportunities for you to get involved. As a public charitable organization, gifts to the Missouri Western State University Foundation are deductible at the highest limits allowed for federal income or estate tax purposes.

Cash Gifts

Cash contributions are the most frequent charitable gift. Checks should be made payable to Missouri Western State University Foundation. The most frequent contributions are to the Annual Fund.

Gifts of Securities – Stocks, Bonds & Mutual Funds

Charitable gifts of stocks, bonds or mutual funds that have been held for at least one year and have appreciated offer special tax advantages. You will receive a tax deduction for the full market value of the gift, but you will not have to pay capital gains tax on the appreciated amount. If you sell depreciated stock and contribute the proceeds, you will receive both a tax deduction for the charitable gift and a deduction for the capital loss.

Gifts of Real Estate

Donations of appreciated homes and other real property are entitled to an income tax deduction equal to the full value of the property and no tax on the capital gain. If debt-free property is donated, the gift is deductible at the property's appraised value. It may even be possible to make your gift of property now but still maintain the right to use the property. By making this gift

now, rather than in your will, you can realize an immediate income tax deduction.

Memorial Gifts

Any gift may be given in memory or honor of a friend or family member.

Gifts-in-Kind

Tangible personal property can be given to support Missouri Western. These gifts may be eligible for a deduction of the item's fair market value, if the gift is related to the charitable purpose of the university. All personal property gifts must be approved by the Foundation.

Corporate Matching Gifts

A matching gift program provided through your employer or board membership may allow you to increase the value of your gift. Many companies match charitable gifts made by their employees, retirees or board members.

Deferred or Planned Gifts

Deferred gifts help insure Missouri Western's future. A deferred gift through an estate plan or life income gift offers you the ability to support Missouri Western but retain the income from those assets during your lifetime.

Will or Revocable "Living" Trust

A bequest contained in a person's will or revocable "living" trust is the most common form of planned gift.

Charitable Remainder Trust

This gift allows you to irrevocably place cash, securities or other property in a trust but keep a specified income for life. This can be done by an annuity trust or unitrust.

Gifts of Life Insurance

Missouri Western can be named as primary or contingent beneficiary of a life insurance policy. Life insurance gifts are simple; just ask the insurance company for the appropriate forms to make the Foundation the owner and beneficiary of a policy. Gifts of a policy are tax deductible, as are future premium payments.

Gifts of Retirement Plans

Naming Missouri Western as a primary or contingent beneficiary of a retirement plan (i.e. IRA, 401(k)) can benefit both Missouri Western and your estate. Your retirement account's plan administrator can help you designate Missouri Western as a beneficiary.
