# The MWSU Foundation



## Composition

**T**he Foundation is led by 31 board members, including Pickman and Dr. Robert Vartabedian, Missouri Western's president. The board consists of eight committees, and all board members serve on at least one committee: Executive, Allocation, Audit, Budget, Bylaws, Committee on Directorship, Development and Investment.

"The committees, along with University Foundation staff, work very hard to ensure that the Foundation is a good steward of all its gifts, and that the gifts are being used according to donors' wishes," Pickman said.

## Foundation funding

**E**ach year, Foundation funds are used for programming, hosting guest speakers or conferences on campus and extra equipment purchases for courses. The Foundation also helps pay for students to present their research at regional, national and international conferences.

## History

**A**lmost 50 years ago, in the same year Missouri Western became a four-year institution and moved to its new campus in 1969, the MWSU Foundation was established to promote private giving and support Missouri Western. It has succeeded in fulfilling those roles ever since.

The Foundation began with less than \$700 in assets, and by 1974, the balance was a little over \$15,000. Today, it has assets totaling more than \$48 million.

"The Foundation's entire history is a story of outstanding support from the community and surrounding region," said Jerry Pickman '85, vice president for University Advancement and executive director of the MWSU Foundation. "That support is why Missouri Western has grown so tremendously and been so successful."





# – what’s it all about?

It also funds, with sponsors, the R. Dan Boulware Convocation on Critical Issues. In 2015, the speaker was Tom Ridge, former governor of Pennsylvania and the first Secretary of the U.S. Department of Homeland Security. The 2016 speaker was political commentator Cokie Roberts.

Funds are also used for student scholarships. In the 2015-16 fiscal year, seven new scholarships were established by donors for a current total of 218. Last year, \$924,087.09 was awarded to 211 students.

While some of the gifts to the Foundation are designated for a particular fund or scholarship, some gifts, especially those given through the phonathon or appeal letters, are undesignated, which may be used at the Foundation’s discretion.

“Undesignated gifts to the Foundation help provide a margin of excellence for our students,” Pickman said. “Those gifts provide many extras for students that may not otherwise be available.”

Last year, for example, undesignated gifts to the Foundation funded a student opera, speakers for a conference, experts to hold masterclasses for students and Eggs and Issues speakers.

The Foundation also supports the Centennial Capital Campaign by acknowledging gifts and pledges, monitoring pledges, preparing reports, and securing documentation.



## Integrity and transparency

Pickman noted that the Foundation strives for transparency and integrity, and it follows best practices to ensure that. Additionally, the Foundation is audited by an outside accounting firm every year.

“Maintaining the public’s trust is very important to fulfilling our mission,” Pickman said. “We have a great responsibility to our donors.”

He said Foundation staff also continually reviews policies and procedures to make sure they are adhering to all federal and state regulations. They thoroughly review their internal practices to maintain a high level of transparency with the board and donors while maintaining donor confidentiality and privacy.

“With our outstanding donor support, the future looks bright for the Foundation and for Missouri Western,” Pickman said. “We are looking forward to seeing what we can accomplish in the University’s second century.”

## 2016-17 Foundation Goals

In May 2016, the Foundation staff held a strategic planning retreat. They reviewed the Foundation mission, values and goals, and established goals for 2016-17:

- Goal 1.** Enhance support for the University’s fundraising efforts.
- Goal 2.** Promote awareness of the Foundation’s mission to internal and external stakeholders.
- Goal 3.** Increase board member engagement and information sharing.
- Goal 4.** Engage in risk management oversight in order to identify, analyze, prioritize and mitigate risks.
- Goal 5.** Maximize the use of technology.





100 YEARS of TRANSFORMING LIVES

**T**he five-year Centennial Capital Campaign, Missouri Western's largest privately funded campaign, began in January 2015, and has been very successful to date. The campaign is positioned to exceed the \$20 million initial celebration goal, one of the focus projects has been completed, and some work has been completed on the second focus project.

The first project, the renovation of Spratt Memorial Stadium, was completed in the spring of 2016 and was funded by private donations and bonding.

Improvements included new field turf, removing the track, moving the visitor side closer to the field, and updating seating on the home side. The stadium building was demolished and a new, approximately 25,000-square-foot, three-story building is now in its place.

The new building includes a larger concourse, a team store, a banquet room, all new media room and coaches room, and larger and more restrooms. The Stadium Club is double the size of the original one, and the new building contains individual suites.

And thanks to the generosity of several donors, the stadium boasts one of the largest video scoreboards in the NCAA Division II. It is the largest scoreboard in the MIAA, and the largest collegiate scoreboard in Missouri. It provides awesome gameday experiences for the football and soccer games.

Steve Craig, benefactor of the Steven L. Craig School of Business and for whom Craig Field is named, pledged the largest individual gift in the history of Athletics to support the scoreboard – \$1.1 million.

The second focus of the Centennial Capital Campaign is Potter Hall, home of the School of Fine Arts. The Potter Hall project is divided into two phases. Phase I is a \$5 million classroom renovation and expansion, and Phase II is a \$10 million addition of a performance facility and lobby.

Potter Hall received several improvements in the common areas – hallways were painted, and new ceiling tiles and carpeting were installed. There were also improvements to the heating and air conditioning systems.

The updates were provided by state funding that was earmarked for capital improvements in common areas, the donation of the



2015-16 membership dues from the Missouri Western Arts Society and private campaign contributions that were designated for the Potter Hall project.

Jerry Pickman '85, vice president for University Advancement and executive director of the MWSU Foundation, noted that work in Potter Hall will proceed as funds are donated to Missouri Western.

"We're very excited about the progress of our Centennial Capital Campaign to date," Pickman said. "We appreciate our donors' support and look forward to future improvements to Potter Hall."

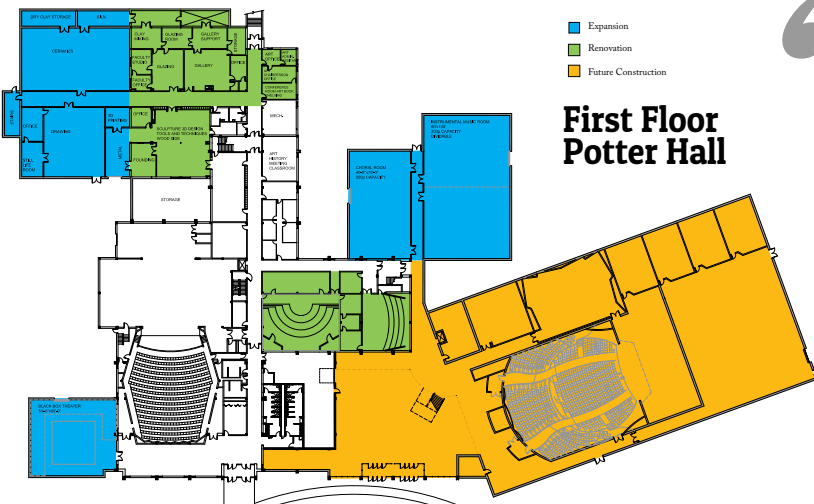




# Campaign Report

## Centennial Capital Campaign Lead Gifts

- \$10 million undesignated pledge from an alumnus in St. Joseph who wishes to remain anonymous.
- \$1.5 million from Mosaic Life Care to endow a professorship in the field of population health. The Mosaic Professorship for Population Health is the first endowed professorship in Missouri Western's history.
- Steve Craig pledged the largest individual gift in Missouri Western Athletics' history – \$1.1 million for a video scoreboard for Spratt Memorial Stadium.
- The Foundation was notified by Jeremiah Krug Reeves, a native of St. Joseph and descendant of the Krug family, that up to \$1 million has been pledged to establish a Walter Cronkite Post-graduate Fellowship.
- Missouri Western employees have pledged more than \$550,000, and the president's cabinet, Board of Governors and Foundation Board of Directors are at 100 percent participation.
- Wayne '90 and Nanette Chatham committed approximately \$500,000 from their estate.
- Bill Wright notified the Foundation that it will be the beneficiary of approximately \$500,000 from his estate. The funds will be used for an endowed scholarship program with students in the arts programs.



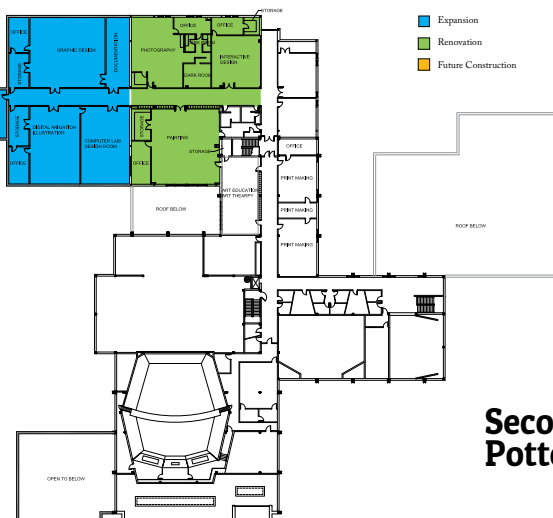

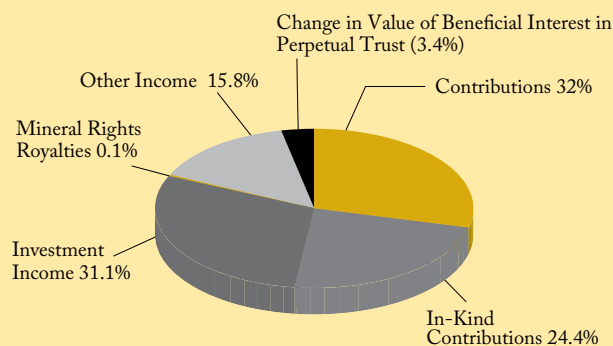

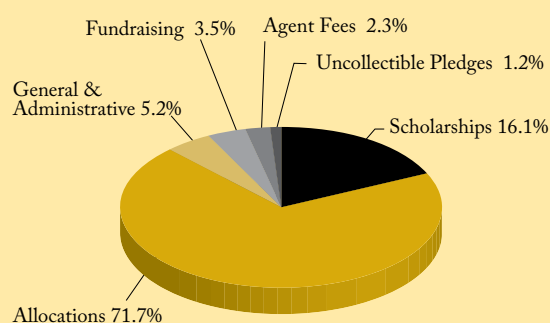

# Ways to Give

*There are many ways you can make a difference through gifts to Missouri Western. From outright contributions to planned giving, there are many opportunities for you to get involved. As a public charitable organization, gifts to the Missouri Western State University Foundation are deductible at the highest limits allowed for federal income or estate tax purposes.*

## Cash Gifts

Cash contributions are the most frequent charitable gift. Checks should be made payable to Missouri Western State University Foundation. The most frequent contributions are to the Annual Fund.

## Gifts of Securities –

### Stocks, Bonds & Mutual Funds

Charitable gifts of stocks, bonds or mutual funds that have been held for at least one year and have appreciated offer special tax advantages. You will receive a tax deduction for the full market value of the gift, but you will not have to pay capital gains tax on the appreciated amount. If you sell depreciated stock and contribute the proceeds, you will receive both a tax deduction for the charitable gift and a deduction for the capital loss.

## Gifts of Real Estate

Donations of appreciated homes and other real property are entitled to an income tax deduction equal to the full value of the property and no tax on the capital gain. If debt-free property is donated, the gift is deductible at the property's appraised value. It may even be possible to make your gift of property now but still maintain the right to use the property. By making this gift now, rather than in your will, you can realize an immediate income tax deduction.

## Memorial Gifts

Any gift may be given in memory or honor of a friend or family member.

## Gifts-in-Kind

Tangible personal property can be given to support Missouri Western. These gifts may be eligible for a deduction of the item's fair market value, if the gift is related to the charitable purpose of the University. All personal property gifts must be approved by the Foundation.

## Corporate Matching Gifts

A matching gift program provided through your employer or board membership may allow you to increase the value of your gift. Many companies match charitable gifts made by their employees, retirees or board members.

## Deferred or Planned Gifts

Deferred gifts help insure Missouri Western's future. A deferred gift through an estate plan or life income gift offers you the ability to support Missouri Western but retain the income from those assets during your lifetime.

## Will or Revocable "Living" Trust

A bequest contained in a person's will or revocable "living" trust is the most common form of planned gift.

## Charitable Remainder Trust

This gift allows you to irrevocably place cash, securities or other property in a trust but keep a specified income for life. This can be done by an annuity trust or unitrust.

## Gifts of Life Insurance

Missouri Western can be named as primary or contingent beneficiary of a life insurance policy. Life insurance gifts are simple; just ask the insurance company for the appropriate forms to make the Foundation the owner and beneficiary of a policy. Gifts of a policy are tax deductible, as are future premium payments.

## Gifts of Retirement Plans

Naming Missouri Western as a primary or contingent beneficiary of a retirement plan (i.e. IRA, 401(k)) can benefit both Missouri Western and your estate. Your retirement account's plan administrator can help you designate Missouri Western as a beneficiary.
