We strive for complete


transparency, and this report is a very important piece of reaching that goal.

Foundation Year in Review 2018-2019

In Fiscal year 2019, the Foundation continued its efforts to support Missouri Western students, and it received many gifts to support those efforts.

- A gift from William Eickhorst, professor emeritus of art, and his wife, Edith, will greatly enhance art majors' educational experience at Missouri Western. The Eickhorsts donated William's print collection that contained more than 1,000 prints. Students helped catalog and inventory the prints, and now have the opportunity to study the works of 20th and 21st century artists.

"As a printmaker, I am all the more impressed with the collection," said Kathy Liao, assistant professor of art. "It is such an incredible resource for the students to be able to witness the vastness and the endless possibilities of printmaking, the lineage and the continued relevancy of printmaking over the years."

- The Foundation helped fund housing for two students when they served as interns in Washington, D.C. this past summer. Mazzie Boyd served as an intern for Sen. Roy Blunt and Alexis Carr worked at the National Portrait Gallery.

"It was incredible. I was so honored to be there," said Carr, an art major. "You can

just feel the history and the significance of what you're doing and where you are."

"I enjoyed serving Missouri; it was the best way I could give back to my state," Boyd said. "In some ways, I feel like I now have a different perspective on life."

- The 26th annual R. Dan Boulware Convocation on Critical Issues was also partially funded by the Foundation. It featured Jon Meacham speaking on "The Soul of America: Moving Beyond Division and Hostility."
- Last fiscal year undesignated gifts to the Foundation helped purchase cinematography equipment and equipment for the library and a

number of classrooms, along with visiting artists, musicians and guest speakers. The Foundation also supported several events that brought high school students to campus – Chemathon, High School Writing Day and Visual Arts Day.

Sally Gibson, director of the library, used Foundation funds to aid students' research and collaboration efforts. The library purchased a television for one of the large group study rooms so students can practice presentations by projecting the information from their laptops





to the television. The library also purchased a white board for a large group study room and three mobile white boards. Gibson said the mobile boards have been very popular with students since they can use them throughout the library.

Eric Fuson, art faculty member, received funding for a small foundry that allows students to pour castings in bronze and aluminum. “Dealing with molten metal at over 1,700 degrees can be intimidating on a large scale,” Fuson said. “With the smaller size, students can manage the entire process themselves, which builds their confidence.” He noted that students being able to use equipment like this in college helps create a seamless transition from student to professional artist.

- In September 2019, Todd Simpson began his duties as the new executive director for the Foundation, replacing Jerry Pickman '85. “Undesignated gifts are essential to our mission,” said Todd Simpson, vice president for University Advancement and executive director of the Foundation. “We not only appreciate the generosity of our donors, but we appreciate the confidence they have in us when they allow us to use their gifts how we believe they will most benefit our students.”

A campaign pledge of \$1 million from Drew Brown, a community member and avid supporter of Missouri Western, was announced at the April 2019 Donor Appreciation Reception. Additionally, in Fiscal Year 2020, the University received a grant for \$1 million from the Sunderland Foundation. Both are for the Potter Hall project. When completed, the Potter Hall annex will be known as the Drew H. Brown Arts Annex.

Since the campaign began, Potter Hall has received several improvements, including an addition of a percussion studio and restrooms. Additionally, thanks to capital improvement funds from the state

and a donation of the 2015-16 membership dues of the Missouri Western Arts Society, several common areas were updated, and there were improvements to the heating and cooling systems.

The campaign also received a \$10 million deferred gift commitment



from an alumnus wishes to remain anonymous, and a \$1.5 million gift from Mosaic Life Care to endow a professorship in the field of population health.

Thanks to public and private support, the campaign funded the renovation of Spratt Memorial Stadium. Work on the stadium was completed in 2016 and included new turf for the field, removing the track around the field, moving the visitor-side bleachers closer to the field and replacing the seating on the home side. Steven L. Craig donated funds for a large video scoreboard and the Bill Snyder Pavilion (dedicated in 2018). The field was named Craig Field in his honor.

A three-story building was also part of the project, and it features a new Stadium Club, which is more than twice as large as the previous space, and individual suites with both indoor and outdoor seating and a serving area. The new facility also contains a Hall of Fame banquet room.

A new Victory Plaza was also created between the stadium and the Griffon Indoor Sports Complex as part of the campaign, and 317 engraved bricks have been sold since it was built.

This past year, campaign funds also helped the Looney Complex arena receive an upgrade, which



included all new seating and bleachers, paint and new graphics. This work was all made possible by an anonymous donor.

"The arena now offers a greater experience not only for fans, but for our student athletes, as well," said Dr. Josh Looney, vice president for intercollegiate athletics. "We appreciate the gift that made the upgrades possible."

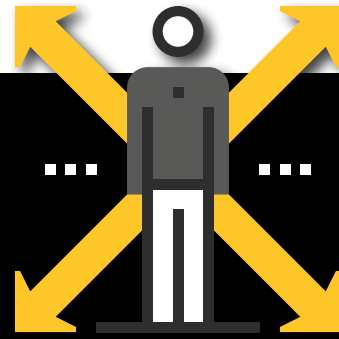
